Subject: **OFFER OF APPOINTMENT FOR THE POST OF CONSTABLE (GENERAL DUTY) IN CRPF.**

As a result of successfully qualifying written examination conducted by the Staff Selection Commission and completion of recruitment process, you have been allotted for enlistment in CRPF. Accordingly, you are provisionally selected for appointment as Constable(General Duty) in CRPF. The post is purely temporary but likely to continue.

02 The pay scale of Constable (General Duty) as per 7<sup>th</sup> CPC lies in the pay matrix-3 and is Rs. 21,700/- as on date. In addition to this, you will be entitled to Dearness Allowance, Ration Money and other allowances as entitled to the Central Govt. employees from time to time and other allowances/benefits as admissible to the CRPF personnel.

- 03 The terms and condition of appointment are as under:-
- a) The post is combatised and purely temporary but likely to continue. On appointment to the said post, you will be on probation for a period of two years. On successful completion of the period of probation, you will be considered for confirmation. Your services are liable to be terminated at any time by the appointing authority without assigning any reasons on one month's notice during the initial period of 02 years in accordance with Central Civil Services (Temporary Services) Rules 1965.
  - b) The appointment carries with it the liability to serve anywhere in India or outside of India.
  - c) On joining this organization you will be governed under CRPF Act-1949 read with CRPF Rules 1955 and other recruitment rules notified/amended from time to time. This joining will be regulated from the date of your joining in CRPF. You have to follow rules, orders and other instructions related to service conditions issued by the department from time to time.
  - d) You will be required to undergo basic training at any of the training institutions of CRPF. If you are not able to undergo/complete the training successfully, your service is liable to be terminated.
  - e) If you intend to resign from service before completion of 10 years of regular service you shall be required to refund to the Government the total cost of training imparted to you in the Force or a sum equal to three months pay and allowances received by you prior to the date of your resignation, whichever is higher.
  - f) On joining the post offered you must meet to the eligibility conditions and be suitable for the post in all respects under provision of the relevant recruitment rules.
  - g) The CRPF has no liability in case of any injury/incident/accident occurred during the transit/journey period for joining the Force.
  - h) On appointment to the said post you will to undergo basic training of specific period. In case you sustain any injury during the period of basic training and you are declared as permanently incapacitated for service in CRPF, your service will be liable to be terminated at any time without notice. It will be dealt according to CCS(Temporary) Service Rules.
  - i) Authenticity of the Education/DOB/Caste Certificates, produced by you shall be verified by the concerned issuing authority. In case of any discrepancy found or malpractice noticed at any stage, your service shall be liable to be terminated. You shall also be liable for action against you as per law.
  - j) Your joining initially for the post of CT/GD is subject to fulfilling all eligibility condition including medical fitness.


- k) You will be entitled to pay and allowances/pension benefits under NCPS (New Contributory Pension Scheme) implemented vide GOI, Ministry of Finance, OM No. F.1(7)(2)/2003/TA/11 dated 07/01/2004. As of now you have to contribute an amount equal to minimum of 10% of your Basic Pay and DA per month towards this scheme.
- l) You will not be entitled for reimbursement of any expenditure for the journey from your home town to the place of joining.
- m) In case you do not report by the stipulated date mentioned at Para-4 below, the offer of appointment made to you will be deemed to have lapsed automatically and no correspondence whatsoever on the subject will be entertained.
- n) In case of OBC personnel the appointment is provisional and is subject to the community certificate being verified through the appropriate authority. If verification reveals that the claim of the candidate belonging to OBC or not belonging to the Creamy layer is false, the service shall be terminated forthwith without assigning any reason and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of false OBC certificate. Only valid OBC certificate is required.
- o) On your appointment, character and antecedents of candidates, other relevant documents will be verified from concerned civil authority and adverse remarks if any noticed, their services will be terminated without assigning any reason.
- p) Your service is liable to be terminated if there is prima-facie proof of having indulged in any malpractice during the any stage of examination.
- q) In case you are found ineligible or suppressing facts on any ground at any time, before, during or after selection/appointment, your candidature/services will be terminated without assigning any reason.

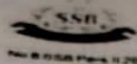

**MEMORANDUM**

The undersigned hereby offers Divisional J. K. Ramesh Kumari Smt. G.O. Smt. K. Ramesh Kumari a post of General Duty in the minimum pay of Rs. 21700-85100, in the Pay Matrix (Level 3, in Sashastra Seema Bai. He/She will also be entitled to draw special allowances, at the rates as admissible to Central Govt employees, subject to the conditions as laid down in the rules and orders governing the grant of such allowances in the Force from time to time.

2 The terms and conditions of appointment are as follows:  
i) On joining the Force, he/she will be governed by the Sashastra Seema Bai Act 2007 & Rules 2009, manuals & other rules orders as issued and amended from time to time by the Government.

ii) The appointment is purely temporary but likely to continue. He/She will be on probation for a period of 02 (Two) years from the date of appointment. The competent authority as prescribed under SSB Rules may, for the reasons to be recorded in writing, extend the period of probation for such further period or periods not exceeding two years or may during the period of probation, terminate his/her services without assigning reasons. His/her permanent appointment to the post, however, will depend upon various factors governing terms of permanent appointment to such post in Force at that time.

iii) His/her services on being a temporary Government servant shall be liable to terminate at any time by a notice in writing given either by him/her to the appointing authority or by the appointing authority to him/her. The period of notice shall be one month provided that the services may be terminated forthwith and, on such termination, he/she shall be entitled to claim a sum equivalent to the amount of pay plus allowances for the period of the notice at the same rate at which he/she was drawing them immediately before the termination of his/her services or, as the case may be, for the period by which such notice falls short of one month.

iv) The competent authority as prescribed under SSB Rules may, having regard to the special circumstances of any case, permit him/her to resign from the Force before completing the term of the engagement provided that while granting such permission the competent authority as prescribed may, require him/her to refund to the Government such amount as would constitute the cost of training given to him/her or three months pay and allowances, whichever is higher. Provided further that he/she on tendering resignation for accepting a job under the Central or State Governments and local bodies, after having been granted cable clearance for the same or who has completed ten years of service shall not be required to refund the sum as provided here in above.

v) On appointment he/she shall be liable to serve in any part of India as well as outside India.

vi) He/She will be governed under New Contributory Pension Scheme for pensionary benefits effective from 01.01.2004.

vii) He/She will have to qualify the Basic Recruit Training Course being conducted by Sashastra Seema Bai within a period of two years from the date of appointment. Not more than two chances will be given to qualifying Basic Recruit Training Course failing which his/her services shall be liable to be terminated.

viii) He/She will have to undergo various training courses, as may be prescribed, from time to time.

ix) He/She will not be entitled to any Traveling Allowance/ Dearness Allowance for joining on his/her first appointment.

x) He/She should bring a Certificate from the local administrative authorities like 1<sup>st</sup> Class Magistrate Sub-Divisional Magistrate - Tahsilidar or any Officer superior to them in the State/Central Government, regarding his/her character and antecedents as per format enclosed, which should have not been issued before six months of date of joining.

xi) The verification of Character and Antecedents would be carried out immediately on joining the service from the concerned District Administration. In the event of furnishing false or incorrect information, at the time of appointment or any facts or statement mentioned by the candidate in the Verification Form being found false or incorrect or any adverse finding is reported against him/her, his/her services shall be liable to be terminated without assigning any reason.

xii) He/She has been selected against the vacancy of - General - category. The appointment is provisional and is subject to verification of Schedule Caste/Schedule Tribe /OBC Certificate if applicable. If the verification reveals that the claim belonging to Schedule Caste/Schedule Tribe or OBC as the case may be is false, his/her services are liable to be terminated forthwith, without assigning any further reasons or without prejudice to such further action, as may be taken under the provisions of the SSB Act, 2007/Indian Penal Code for production of false certificate.

xiii) For Other Backward Classes candidates, the Community Certificate should invariably be issued by the designated authority only. If on verification it is revealed that his/her claim of belonging to Other Backward Classes and not belonging to Creamy Layer is false, his/her services will be terminated forthwith without assigning any further reasons or without prejudice to such further action as may be taken under the provisions of SSB Act 2007 / Indian Penal Code for production of false certificate.

xiv) He/She should bring Verification Roll form enclosed; obtaining signatures with seal on the Identification Certificate by any Gazetted Officer as mentioned in the certificate at page 4 of Verification Roll.

xv) For women candidate only, Those woman candidates who appear for joining in pursuance to the Offer of Appointment and as a result of tests is found to be pregnant of 13 (thirteen) weeks standing or over shall be declared -Temporary Unfit- and her appointments shall be held in abeyance until the confinement is over. She should be re-examined for a fitness certificate six weeks after the date of confinement, subject to the production of a medical certificate of fitness from a registered medical practitioner. Those women candidates who is found to be pregnant of period less than 12 (twelve) weeks standing will be allowed to join but will not undergo BRTC at the time of her joining. She will report back to her unit in case if joined at Training Centre.
